



## Signal Mountain Lodge Pet Policy

All guests bringing pets to Signal Mountain Lodge are subject to the following guidelines:

1. Guests will pay a non-refundable pet fee of \$20.00 per night. Guests will also pay an additional fee determined by management in the event of special cleaning or repair due to pet hair on the carpet, curtains and/or furniture and/or due to other types of damages caused by the pet.
2. Pets are not allowed in any Upper Lakefront Retreat or Premier Western Room. Guests who have an Upper Lakefront Retreat or Premier Western Room reserved are not allowed to have a pet even if they do not bring it into the room. Pets are not allowed to be kept on decks and/or in vehicles.
3. Pets are only allowed in the room # listed on this signed form. If the pet will be in any other room # at any time during your stay, that room # must be added to this form and the pet fee will be charged for all rooms for every night of the reservation. Additional cleaning fees apply to all rooms.
4. Pets must be kept away from all dining areas and should not be brought inside any Signal Mountain Lodge building, other than the room # listed on this form.
5. Dogs and Cats are acceptable. All other pets are subject to management's approval.
6. Signal Mountain Lodge maintains a STRICT no biting, no barking policy for pets.
7. Pets left unattended in room must be kept in a crate and dogs must not bark at a level audible outside of the room including at a level that neighbors sharing walls would hear. Pets may not be left unattended in a vehicle at any time.
8. Housekeeping will not service a room in which a pet is left unattended even if crated. Guest must be present.
9. Pets are NOT allowed to be tied outside and left unattended when the owners are not present.
10. All pet waste must be cleaned up immediately and disposed of properly (bagged, secured shut and disposed of in lined trash receptacle).
11. Pets should be comfortable with the presence of people and animals walking by the room constantly. All rooms are in areas frequented by both staff, guests, and are in the middle of the National Park, where there is an abundance of wildlife. This presence should not be upsetting to the pets and should not cause dogs to bark at a level audible outside of the room including at a level that neighbors sharing walls would hear.
12. All pets, when outside of the room, need to be on a leash or physically restrained at all times.
13. Caution should be taken when hiking **outside of the park** with dogs (dogs are not allowed on trails within Grand Teton N.P.) because wolves and other wildlife can be aggressive towards domestic dogs.
14. All guests' bringing pets must provide evidence of updated vaccinations if requested.
15. Dogs and cats must have identification or a nametag and a collar, and a current rabies tag must be worn by both at all times.
16. Pets are not allowed on any rental boats, Scenic Float trips or Guided Fishing trips at Signal Mountain Lodge.
17. All guests with pets must sign a waiver and provide Signal Mountain Lodge and Forever Resorts with an indemnification so that the lodge is not responsible for any injury or damage the pet may cause to the property, staff or guests.

## Service Animals

Service Animals are not considered pets per ADA specifications and are not subject to the policies listed as long as the animal's behavior does not pose a direct threat to the health or safety of others and does not result in a fundamental alteration to the nature of our business (i.e. barking). Guests with Service Animals must adhere to all ADA regulations regarding service animals.

*Grand Teton National Park is a wild and special place – legally mandated to protect park resources. Pets may disturb wildlife or escape and quickly become prey. Follow all pet regulations. See the map provided on the Pets in the Park pamphlet for suggested areas for exercising your pet in or near the park. Always leash your pet and dispose of pet feces properly.*

**Grand Teton National Park Pet Regulations**

1. You are responsible for clean-up and disposal of pet feces. Mutt Mitt stations may be provided, but plan to bring your own bags for pet waste disposal.
2. Pets must be kept under physical control at all times—caged, crated or restrained on a leash not to exceed six (6) feet in length.
3. Pets are prohibited in the backcountry and on park trails.
4. Pets are prohibited from public buildings and swimming beaches.
5. Pets must stay within 30 feet of any roadway.
6. Pets are prohibited from riding in boats on park waters, except for Jackson Lake on a permitted vessel.
7. Pets must not be left unattended and/or tied to an object.
8. Pets are prohibited from making unreasonable noise or frightening wildlife.
9. Pets running-at-large may be impounded and their owners charged for their care and feeding.
10. Dog sledding is prohibited.
11. Pets are not allowed on the multi-use pathway.
